## 3 Enclose the booth fee with your application. Checks will be cashed upon artist acceptance into the show. Be sure to include an extra \$10 if you plan on renting a table from Turtle Creek. **Please make checks payable to: Amy Guanci**

Entrance Fee is determined by the size and location of booth space:

- \$25.00 Outdoor space
- \$40.00 Indoor space, 6' space or unusual-shape
- \$60.00 Indoor space, L-shape, approx. 8' x 6'
- \$80.00 Indoor space, approx. 9/10' x 9/10'
- \$10.00 Additional fee for Table Rental (optional)

Spaces in this show are variable because of this unique building, and may not be exact.

Adjustments may be made on the day of the show depending upon adjoining artist setups.
